

**Library Cluster Meeting Minutes**

**Approval of Agenda :**

**Approval of Minutes :**

**LINCC – Masking *Find Text* : (Alicia)**

**TBLC Annual Meeting : (Jeneice)**

Jeneice shared a summary of the TBLC Annual Meeting with the cluster. The keynote speaker, David Lee King, was the highlight of the program. He is a regular speaker on Web 2.0/Library 2.0 topics. "Web 2.0 is not about technology, it's about building community through communication, conversation and participation." Interesting websites were shared for exploring more about Mr. King and Web 2.0.

Pending approval, the course will be taught online and will be pass/fail (requirement of connections courses). ### **Information Literacy : (Jacquelyn)**

The libraries have created one video so far. According to Jacquelyn's notes, we have 7 more to create. Jacquelyn will contact the info lit subcommittee members to decide who will be responsible for which video. Jacquelyn will contact Celeste Fenton to get information about the timeframe for creation of the videos. Librarians were not in favor of creating videos during the summer.

### **Ebooks : (Wendy)**

The HCC deselection list was approved by cluster and is now with Mario for removal.

### **Roundtable:**

Vic reported that Jim Shimkus is leaving HCC to join his wife in Indiana. He has accepted a librarian position at Ball State University.

Jacquelyn provided an update on the College Success and Retention Committee meeting. Mr. Ray distributed a handout with suggested readings for the committee. Jacquelyn will check the libraries' holdings of the suggested materials.

Jacquelyn also reported that she participated in the Great American Teach-In at Middleton High School. She had yet another terrific experience and encouraged the librarians to participate in the future.

Kristin reported that Plant City is working with the public library to write a grant proposal for the NEA Big Read. She also reported on the memorial collection that was purchased by faculty, staff and administration in memory of Dr. Maribeth Mobley's father.

Alicia reported that she and Judy Nolasco were approved for FSPD funds to travel to the 2008 TYCA-SE (Two-Year College English Association) conference that they are presenting at in Louisville. An article about their presentation and cooperation will be in the next issue of the LampPost – the Ybor Campus Paper.
